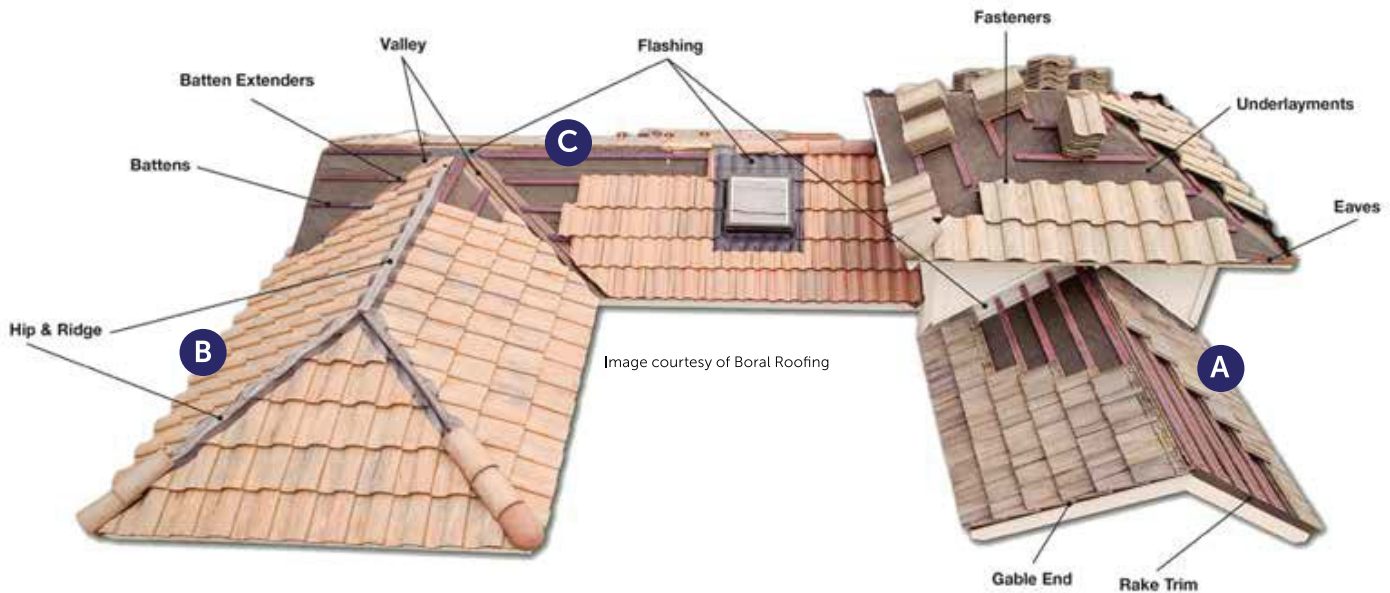

THE EFFECTS OF WIND & STORM DAMAGE

Displaced tile and shingles can cause leaks and will sustain much less wind speeds. This makes your roofing system more susceptible to further and future damage.



A Wind damage shows up as broken, cracked or displaced tiles or shingles. Broken tiles may be evident but lifted tiles can be harder to see.

B Ridges, eaves, corners and rake edges are most susceptible to wind damage.

C Once tiles have been damaged or lifted, the underlayment gets exposed which leads to leaks that cause rot and interior damage.

Your property is then fully restored, with labor backed by our exceptional warranty.

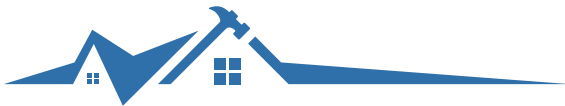
FINAL INVOICE

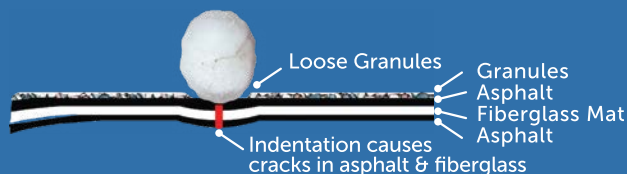

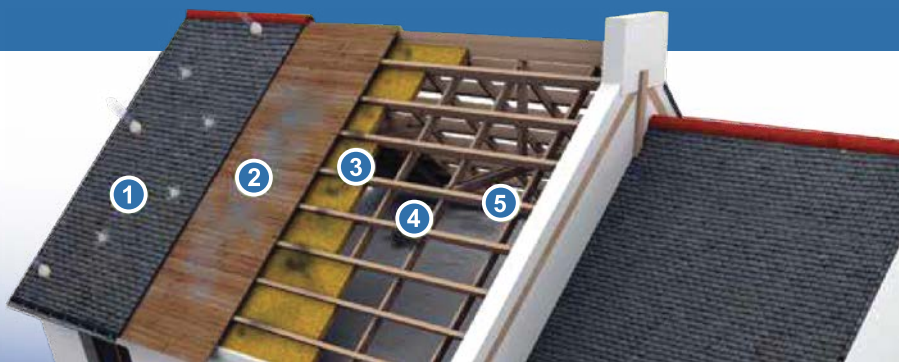


EFFECTS OF HAIL TO AN ASPHALT SHINGLE

When hail hits a shingle, the shingle gets "bruised" much like an apple. The granules get knocked loose, the fiberglass mat gets cracked, and over time, the asphalt wears away and causes leaks in your roof.



1. Hail cracks shingle
2. Water saturates the underlayment
3. Decking begins to rot
4. Water seeps into home, growing mold
5. Interior damage begins

FREQUENTLY ASKED QUESTIONS

Going through a storm can be a challenge. Here are answers to some questions you may have. Your friendly rep will be happy to answer any others, just ask!

#1 DO I NEED TO CALL MY AGENT?

Most insurance companies have a claim center to handle storm claims. They are usually open 24 hours and can get the process started.

#2 WILL FILLING A CLAIM COST ME MONEY?

Simple, no. The insurance company is paying for your restoration. The only cost is your insurance deductible.

#3 WILL MY RATES GO UP?

Homeowner's insurance does not act like auto insurance. If the premiums are raised, it is done in bulk for a given zip code, not individually. Insurance companies can only submit rate increase once per year. It is possible your rate may go up even if you do not fill a claim.

#4 WHAT IS THE DEDUCTIBLE?

The deductible is a portion of money that the insurance company withholds from the total amount paid on a claim. The amount of the deductible varies based on the policy you selected.

#5 DO I NEED TO GET AN ESTIMATE?

The adjuster who inspects your home will provide an estimate for repair. Evolve Construction and Restoration will review this estimate, if changes are needed. Evolve Construction and Restoration will provide the necessary required information to the insurance company via process called supplementing.

#6 WHAT IS DEPRECIATION?

The insurance company determines the depreciation based on a combination of objective criteria (using a formula that takes into account the category and age of the property) and subjective assessment (the insurance adjuster's visual observations of the property or a photograph of it). The insurance company will withhold depreciation as an incentive to get the property owner to complete the job correctly. You will be able to collect the depreciation held by the insurance company when the job is completed.

#7 WHAT IS ACV?

Actual Cash Value (ACV), also known as market value, is the standard that insurance companies prefer when reimbursing policyholders for their losses. Actual

cash value is equal to the replacement cost minus any depreciation. (ACV = replacement cost - depreciation) and is the initial money you receive from the insurance company.

#8 WHAT IS RCV?

Replacement Cost Value (RCV), simply stated, means the cost to restore the damage to your property with materials of the same quality. RCV is the Actual Cash Value plus (+) the depreciated value. This is the total amount to which you are entitled when the job is complete.

#9 WHAT IS SUPPLEMENTING?

During the repair to your property factors such as building code requirements, labor consideration, and additional material needs may be needed. Evolve Construction and Restoration will present these needs along with appropriate documents to the insurance company in the form called supplement.

#10 WHY IS MY MORTGAGE COMPANY ON THE CHECK?

The mortgage company has a financial interest in your property and the insurance company may include the mortgage on any checks they issue you. If this is the case, you will need to communicate with your mortgage company to get them to endorse the check. Many times they will send you a packet of information explaining their endorsement policies. In the end, the mortgage company wants to ensure you abide to the pricing and scope of work approved by the insurance. Evolve Construction and Restoration is ready with the proper forms and assistance to help you with this process.

#11 WHAT TYPE OF DOWN PAYMENT DO I NEED?

On most insurance claims, Evolve Construction and Restoration collects the full ACV check amount as well as your deductible, which allows us to order materials and start your project. Even though your insurance company will hold back funds to insure that Evolve Construction and Restoration completes your project, your peace of mind throughout the project is our priority. This means Evolve Construction and Restoration is open to discussing alternative down payment financing options.

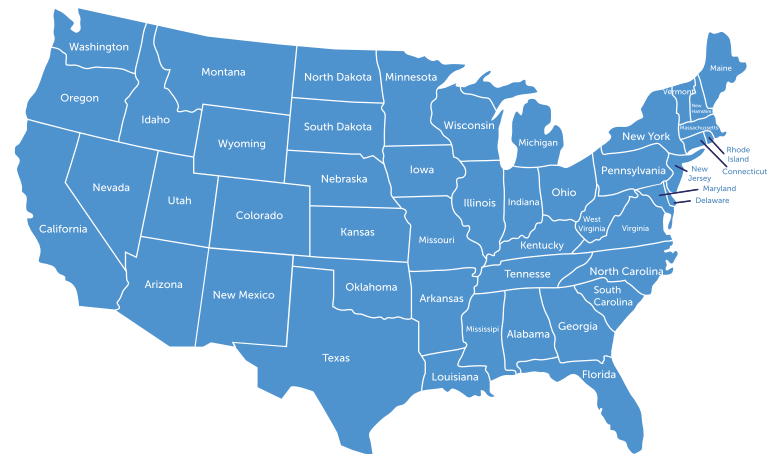
